## Notice of Change in Consolidated Subsidiaries (Share Transfer)

GMO Pepabo, Inc. (the "Company") hereby announces that on July 22, 2025, it resolved to enter into a share transfer agreement to transfer all the shares it holds (the "Share Transfer") in GMO Creators Network, Inc. ("GMO Creators Network"), a consolidated subsidiary of the Company. The proposal for the Share Transfer was unanimously approved in writing by all Directors and, under Article 370 of the Companies Act and Article 27 of the Articles of Incorporation, was deemed to have been passed by a resolution of the Board of Directors. The Share Transfer requires approval at the general meeting of shareholders of CN Inc., a consolidated subsidiary of the Company, scheduled for July 31, 2025.

#### 1. Reasons for the share transfer

Since its founding in 2003, the Company has been operating in the Domain and Rental Server (Hosting) business, E-commerce Support business, Handmade Products business, and Financial Support business to provide an environment that fosters self-expression and self-actualization for many individuals.

GMO Creators Network offers the FREENANCE byGMO service, which supports freelance workers and sole proprietors by providing same-day payment factoring and liability insurance.

The Company has evaluated its business portfolio, optimized its management resources, and identified key areas on which it will focus. The Company has also reviewed the future of GMO Creators Network and decided to transfer its shares in the company, expecting that GMO Creators Network will explore new opportunities to enhance its services.
